MRI OF THE NECK AND FACE WITH AND WITHOUT CONTRAST.

INDICATION: Non-Hodgkin's lymphoma.

The following sequences were obtained:

Pre-contrast

1. Coronal, STIR, 8 mm.
2. Coronal, T2, 8 mm.
3. Axial, multiecho, 8 mm.

Post-contrast

1. Sagittal, T1, 6 mm.
2. Coronal, T1, 8 mm.
3. Axial, T1, 8 mm.

There are bilateral masses within the cervical lymph node chains. The right lymph node chain is entirely filled with large, medium, and small sized nodes, which reveal mild contrast enhancement on post-contrast administration. The nodes extend from the base of the skull beneath the mastoids to the suprACLAVICULAR fossae bilaterally. They are larger and more multiple on the left than on the right. They involve both the anterior and posterior cervical chains. There is also a single small, possibly pathological occipital lymph node seen on the right. The mass of nodes abuts upon the thyroid on the right anteriorly. The parotid and submandibular glands appear normal but, again, the lymph nodes on the right do abut upon the submandibular glands.

The pharynx, larynx, and trachea are within normal limits. The maxillary sinuses are unremarkable. The musculoskeletal structures are intact. No vascular abnormalities are identified.

IMPRESSION: Bilateral lymph nodal enlargement and increase in number, consistent with non-Hodgkin's lymphoma. There does not appear to be extranodal distribution of neoplastic tissue.
